

Half-year statement of the liquidity contract

Pontpierre, France, July 11th 2023 – La Française de l'Énergie (Euronext : FDE – ISIN: FR0013030152) announces that the Company's liquidity account, which is managed by TP ICAP (Europe) under a liquidity contract, included the following Company common shares and cash as of June 30st 2023:

- 1,755 shares,
- 122,625.30 euros in cash.

During the 2nd half of 2023, the following has been negotiated:

- Buy side: 9,356 shares for a total of 380,388.55 € (309 transactions),
- Sell side: 10,962 shares for a total of 450,053.90 € (317 transactions).

- 52,988.75 euros in cash.
